**TARUNA GARG OF MURTHA CULLINA CHOSEN AS DIVERSITY HERO

**BOSTON, MA (April 27, 2010)...** Taruna Garg, an Associate at Murtha Cullina LLP, was chosen as a 2010 Diversity Hero by Massachusetts Lawyers Weekly, a legal publication widely circulated among the Commonwealth's legal community.
