She was also the Finance Assistant for Jack Reed for U.S. Senate where she assisted raising \$1.1 million from in-state individual donor program and developed and executed "Get Out The Vote" efforts for the state party and for the campaign.

Ms. Gemski received her B.A. from Clark University and interned at the Office of Greville Janner, Queen's Court, Member of Parliament in London, England.
