Joe regularly advocates on behalf of clients in state and local administrative proceedings and judicial proceedings, including appeals filed with the Connecticut Appellate Court and Connecticut Supreme Court. He often represents municipalities and government officials before the Connecticut Freedom of Information (FOI) Commission; municipal boards of assessment appeals; municipal planning and zoning commissions; and other administrative agencies hearing Uniform Administrative Procedure Act (UAPA) cases. Representing both defendants and plaintiffs, he advises retail and skilled nursing home clients in landlord-tenant, collection and other disputes. In addition to representing various corporate entities and individuals in general litigation involving disputes over contractual and real property rights, Joe regularly represents clients in Connecticut property tax disputes.

In 2022, Joe was appointed to a one-year term as the independent consumer advocate for The Metropolitan District of Hartford, Connecticut (MDC), a nonprofit municipal corporation responsible for the region's water and sewage services. In this role he represents MDC consumers' interests concerning water quality, water supply and wastewater service quality.

Sought-after for both his legal and industry insight, Joe also shares his knowledge with government officials and community leaders, and he has both presented at professional organization events and written articles about topics of interest in his practice areas.
